Like Bill Murray in 'Groundhog Day' I'm back again. 40 years ago (1980) I was a young loan officer at First National Bank of Maryland (now M&T Bank). That was the year that then-Maryland Governor Harry Hughes decided to start a Sister State relationship with Anhui Province in China. The bank's president was asked to join the delegation and, because of my military (Vietnam War) and education (MA Politics and Asian Studies at New York University) background in Asia, I was asked to leave my domestic lending position and take over management of the bank's Asia-Pacific Division. In 1985 I was asked by then-Mayor William Donald Schaefer to join his delegation to start a Sister City relationship with Xiamen, China. On return I was one of the founding members of the Baltimore-Xiamen Sister City Committee. In 2015 I was also, along with Gislin Dagnelie (BRSCC), Rachel Sengers (BRSCC) and Dan Young (BKSCC), a founding member of BSC. At year end 2019 I 'retired' from the BSC board but continue as an active member of BXSCC.

Working with me in the Secretary position will be Acting Assistant Secretary Athar Bayoumi. Athar was born in Egypt, raised in Maryland and is a member of BLASCC. She was the Advertising Assistant at *Baltimore* magazine until May 22 when they furloughed half of their staff due to COVID-19.

At *Baltimore* magazine Athar had considerable experience with G Suite. She is a graduate of Stevenson University (BS Business Administration with a double major in marketing and management). While at Stevenson Athar had internships at *Baltimore Business Journal* and Habitat for Humanity.

Initially I plan to focus on managing the G Suite program and Athar will handle board meeting administration. We will work together on G Suite Contact Lists and internal communications. We will share the secretary@baltimoresistercities.org account. You can come to either one of us with any Secretary problems or questions. Some of the things Athar and I want to work on include improving communications with committee secretaries, making G Suite more user friendly, and encouraging more committees to use G Suite for their internal administration and record keeping. Sometime soon we will hold a second G Suite Workshop. Meanwhile we encourage any G Suite feedback or suggestions.

One suggestion from a BLASCC member is growing into a multi-faceted collaboration to provide

assistance and support to Baltimore's refugees and immigrants.

BLASCC member Kate Campbell Stevenson was the longtime board chair for Empowered Women International, a nonprofit in the



Washington, D.C. EWI provides business training and support to immigrant, refugee and other marginalized women. As EWI

expanded its services to Baltimore, Kate imagined collaboration possibilities with BLASCC. Just a few months later, two of our members – Delila Khaled and Athar Bayoumi – are using their business and advertising skills to offer feedback to EWI trainees on perfecting their business pitches and financial plans.



This led to further outreach to the Mera Kitchen Collective, a Baltimore worker cooperative in which immigrant chefs work together to provide catering services. Since the pandemic began, Mera Kitchen has used a GoFundMe campaign to prepare meals for Baltimore communities and frontline health workers. BLASCC is investigating ways we can help provide these new Baltimore residents - the Mera Kitchen chefs - with training in personal financial literacy, conflict resolution and the Black Lives Matter movement. Geri Byrd, BSC Vice President and the Mayor's Chief of Staff for Administration, and Catalina Rodrigues-Lima, Director of the Mayor's Office of Immigrant Affairs (MIMA), have been supporting our discussions.


# Functional Championships Program - Gearing Up
